During school closures, St. Thomas Syro Malabar Catholic Diocese of Chicago makes efforts to provide families with student assignments and other instructional materials through various delivery methods, including online. This form allows parents/guardians to grant permission for schools to deliver this online content with parents for delivery to their children and recognize schools' responsibilities under the **Children's Online Privacy Protection Act**.

The parishes/missions should follow responsibilities for preventing students from accessing obscene or harmful content by personal sharing or internet connections.
